Regulations for the Use of Camp Wetoga

It is imperative that the signer of this document read and abide by the following instructions. Failure to do any of the following will result in extra charges for required repair or replacement. The board of directors is committed to preserving the property and facilities for future guests.

- All buildings, grounds and recreational areas must be cleaned after use. Leave things as they were and where you found them.
- Any damages, uncompleted cleaned, broken or stolen property will be the responsibility of the renter.
- Proper care and respect must be given to all Camp Wetoga property including grounds, recreation and sports equipment. Some examples include: Do not mark, cut or write on cabins, craft shed, furniture, trees, etc.
- Any buildings not leased by renter are strictly off limits.
- Damaged and broken items must be reported.
- Waiver of Liability must be obtained from each family attending Camp Wetoga.
- No pets.
- Do not drive on grass.
- Swim at own risk and only in designated areas. Swimming must be supervised by a lifeguard.
- Fires are to be built in designated areas and only with the consent of the Camp Caretaker.
- No fires are to be built when Fannin County is under a burn ban.
- No smoking, no tobacco products, no alcohol, no illegal drugs.
- No firearms or weapons of any kind are permitted.
